Proceedings of the 9th Technical Support Group (TSG) of RUSA meeting held Under the Chairmanship of Dr. S.A.Kori, Executive Director, KSHEC on 01.12.2016 at 3.00 PM in the Conference Hall of Karnataka Higher Education Council, Bangalore

The Chairman welcomed the members and started the proceedings by taking the Agenda

- 1. Chairman reviewed the Physical and financial layout submitted by all the 9 Universities and progress of work.
- 2. All the Universities were asked to submit the utilisation of RUSA funds as on 30.11.2016 immediately.
- 3. All the Universities have uploaded only few high Quality Photographs, which is not satisfactory. Hence the Universities were informed to upload the good quality of photographs in the Bhuvan app.
- 4. Universities were asked to submit the correct data for the output-outcome matrix, which is to be submitted to MHRD, New Delhi.
- The format sent by MHRD regarding Gender Atlas were discussed and circulated to all Universities, DCE and DTE, requested them to submit the information sought in this regard immediately.
- 6. RUSA Co-ordinator, DCE was asked to submit the Data Capture Format (DCF) and Physical and financial layout of the recently NAAC Accredited Government and Government Aided Colleges immediately as it is to be forwarded to MHRD for funding under RUSA.

The Commissioner, DCE has informed about the status of the Physical and financial layout of the 90 GFGC as below.

(i) Part A – New construction – 35% (Rs. 70 Lakhs):-The colleges have submitted the proposal for new constructions for some of which CCE has already given administrative approval, which is as per the RUSA guidelines. They have to be executed as per KTTP rules by the respective Government/ Central agencies.

- (ii) Part B Renovation/upgradation 35% (Rs 70 Lakhs):The colleges Principal has to submit the detailed estimation, which may be approved by CCE if it is in within the limits of RUSA guidelines. Otherwise the college Principal will be asked to resubmit the revised estimation for taking further action in the matter.
- (iii) Part C Procurement of ICT equipments, books 30% (60 Lakhs):The books, Laptops & other equipments needs to procured after getting the requirement from each colleges and which needs to be approved by the Technical Committee formed in the Dept of Collegiate Education. With respect to the issue of equipments already purchased for smart class room during the month of February 2016 by the Principals, the facts may be submitted to the Govt /SPD to take further necessary action and directions.

He also mention that the some of the colleges have withdrawn excess amount from the previlage account of Canara Bank, Madhavangar Branch, Bangalore. The concerned college Principals will be asked to give explanation and each case has to be decided on its individual merit.

He expressed that the balance money available in each college has to be spent for civil works only, so that there is no delay in the process. The Executive Director clarified that if the amount deposited in Govt. agencies (Like KRIDL, KHB, PWD, Nirmithi Kendra) for construction/renovation activities as per Government procedures, the deposited amount may be shown as expenditure.
