ವಿಷಯ:- ಪ್ರತ್ಯೇಕ ಅಧಿನಿಯಮದ ಮೂಲಕ ಖಾಸಗಿ ವಿಶ್ವವಿದ್ಯಾಲಯಗಳನ್ನು ಸ್ಥಾಪಿಸುವ ಸಂಬಂಧದ ಮಾರ್ಗಸೂಚಿಗಳಿಗೆ ಅನುಮೋದನೆ ನೀಡುವ ಕುರಿತು.

ಖಾಸಗಿ ವಿಶ್ವವಿದ್ಯಾಲಯಗಳ ಸ್ಥಾಪನೆ ಕುರಿತು ಕರಡು ನಿಯಮಗಳನ್ನು ರಚಿಸಲು ನೇಮಿಸಲಾಗಿದ್ದ ಸಮಿತಿಯು ತನ್ನ ಶಿಫಾರಸ್ಸುಗಳನ್ನು ಸಲ್ಲಿಸಿದ್ದು, ಸದರಿ ಶಿಫಾರಸ್ಸುಗಳಿಗೆ ದಿ: 5-5-2016 ರಂದು ಜರುಗಿದ ಪರಿಷತ್ತಿನ 16ನೇ ಸಾಮಾನ್ಯ ಸಭೆಯು ಅನುಮೋದನೆ ನೀಡಿರುತ್ತದೆ. ಸದರಿ ಕರಡು ನಿಯಮಗಳಿಗೆ ಮತ್ತು ಇದಕ್ಕೆ ಸಂಬಂಧಿಸಿದ ನಿಗದಿತ ನಮೂನೆಗಳಿಗೆ ಹಲವಾರು ಅಂಶಗಳನ್ನು ಮಾರ್ಪಾಡು/ಸೇರ್ಪಡೆ ಮಾಡಬೇಕಾಗುತ್ತದೆ. ಸದರಿ ಕರಡು ನಿಯಮಗಳನ್ನು/ಮಾರ್ಗಸೂಚಿಗಳನ್ನು ಅಧಿನಿಯಮಗಳಿಗೆ ಹಾಗೂ ನಿಗದಿತ ನಮೂನೆಗಳಿಗೆ ಸೇರಿಸದಿದ್ದಲ್ಲಿ ವ್ಯತಿರಿಕ್ತವಾಗುತ್ತದೆ. ಸಂಬಂಧಪಟ್ಟ ಖಾಸಗಿ ವಿಶ್ವವಿದ್ಯಾಲಯದ ಅಧಿನಿಯಮಗಳಿಗೆ ತಿದ್ದುಪಡಿ ತಂದು ಸೇರಿಸಬೇಕಾಗುತ್ತದೆ. ಆದ್ದರಿಂದ ಅಧಿನಿಯಮಗಳಲ್ಲಿ ಕೆಲವು ನ್ಯೂನತೆಗಳಿರುವುದರಿಂದ ಅವುಗಳನ್ನು ಸಹ ಗಮನಿಸಿ ಈಗಾಗಲೇ ರಚಿಸಲಾದ ಸಮಿತಿಯ ಮುಂದೆ ಮಂಡಿಸಿ ಅಧಿನಿಯಮಗಳಿಗೆ ಉದ್ದೇಶಿತ ತಿದ್ದುಪಡಿಗಳನ್ನು ಸಮಗ್ರವಾಗಿ ಸೂಚಿಸಬಹುದಾಗಿದೆ. ಖಾಸಗಿ ವಿಶ್ವವಿದ್ಯಾಲಯದ ಸ್ಥಾಪನೆಯ ಕರಡು ನಿಯಮಗಳಲ್ಲಿರುವಂತೆ ಅಧಿನಿಯಮದಲ್ಲೂ ಸಹ ತಿದ್ದುಪಡಿ ತಂದು ವ್ಯತಿರಿಕ್ತವಾಗದಂತೆ ನೋಡಿಕೊಳ್ಳಲು ಅನುಮೋದನೆ ನೀಡುವಂತೆ ಕೋರಿ ಸರ್ಕಾರಕ್ಕೆ ಪ್ರಸ್ತಾವನೆ ಸಲ್ಲಿಸಿರುತ್ತಾರೆ.

GUIDELINES FOR THE ESTABLISHMENT OF PRIVATE UNIVERSITIES BY SEPARATE ACT

PREAMBLE -

Ever since Indian Independence, providing education to the children has been the prime focus of the country. In order to enhance equitable access and to ensure the fulfilment of national social goals, obligations as well as purposes, the private sector has been encouraged to invest in the sphere of education, at different levels, viz., primary, secondary and higher. It is a matter of satisfaction that several private sector players have already started their educational institutions to cater to education requirements of the needy at all the three levels. The Karnataka State has been one of the early champions in engaging the private sector to complement and reinforce its efforts. To provide greater autonomy to private sector for achieving global standards of excellence in higher education, the concept of establishing State Private Universities has been introduced by Karnataka State Government. In order to establish transparent and accountable academic, organizational and financial management systems in State Private Universities, KSHEC has formulated the following guidelines:

1. Each Private University in Karnataka shall be established under a separate Act by a Sponsoring Body which may be in the form of:
 - (a) *Society registered under the Societies Registration Act 1860 (or any other corresponding law in force in the State), OR*
 - (b) *Public Trust registered under the Public Trust Act, 1866, OR*
 - (c) *Company registered under Section 25 of the Companies Act, 1956.*
2. The Sponsoring Body can apply to Karnataka State Government through KSHEC for the establishment of a Private University, if it has
 - *25 Acres of land within the limits of Bruhat Bengaluru Mahanagara Palike (BBMP) and Bengaluru Metropolitan Regional Development Authority (BMRDA) OR 35 Acres of land within City Corporation Limits of Mysuru, Mangaluru, Hubballi, Bellari, Gulburga, and Belagavi OR 50 Acres of land at other places*
 - *adequate financial resources for creating the specified Statutory Funds and conducting the University affairs and*
 - *experience/ expertise in running higher Education Institutions.*
3. The Sponsoring Body shall obtain the proposal format for the establishment of State Private University from KSHEC on payment of non-refundable fee of Rs. TEN THOUSAND ONLY in the form of Demand Draft drawn in favour of Executive Director, KSHEC, Bengaluru payable at Bengaluru.
4. The Sponsoring Body shall submit SEVEN HARD COPIES AND ONE SOFT COPY of the proposal along with requisite Annexures, Enclosures, Undertakings and Declarations to the Executive Director, KSHEC, Bengaluru along with a non-refundable PROCESSING FEE of Rs. TEN LAKHS ONLY in the form of Demand Draft drawn in favour of Executive Director, KSHEC, Bengaluru payable at Bengaluru with ONE HARD COPY AND ONE SOFT COPY to the Secretary/Principal Secretary/Additional Chief Secretary of Higher Education Department, Government of Karnataka.
5. The office of the Executive Director shall examine the proposal and may call for such other information from the Sponsoring Body as it may deem necessary to initiate further action.
6. The Executive Director, in consultation with the Vice Chairman and the Chairman of KSHEC, shall constitute a Screening Committee with a minimum of FIVE members consisting of Vice-Chancellors / former Vice-Chancellors / Education Experts including Executive Director of KSHEC as Member Secretary to carry out on-the-spot inspection and submit a report.
7. The Executive Director shall forward the Screening Committee Report to the Secretary/Principal Secretary/Additional Chief Secretary of Higher Education for further action.
8. The Secretary/Principal Secretary/Additional Chief Secretary shall communicate to the Sponsoring Body about the final decision of the State Government on the proposal.


